Bylaw #2016-010

BEING A BYLAW OF THE VILLAGE OF FORT SIMPSON, A MUNICIPAL CORPORATION IN THE NORTHWEST TERRITORIES, TO SET THE SCHEDULE FOR REGULAR SCHEDULED MEETINGS FOR THE 2017 CALENDAR YEAR.


WHEREAS Procedural Bylaw#01-2013, governs the calling, place and proceedings of regular scheduled meetings.

AND WHEREAS Council for the Corporation of the Village of Fort Simpson deems it advisable to establish the schedule of Regular Council Meetings for the year 2017;

NOW THEREFORE BE IT RESOLVED That the Council of the Corporation of the Village of Fort Simpson enacts as follows:

1. That the 2017 notice of schedule of meetings for Regular Meetings, Regular Committee of the Whole Meetings and Regular Budget Meetings , as set out in Schedule "A" shall be the official dates of the regularly scheduled public meetings of the municipal council for the year 2017.
2. Council may, by resolution, change the time, date or location of any regular meeting of Council, or cancel a regular meeting, provided that notice of change is given at least seventy two (72) hours in advance of the meeting.
3. Should a Regularly Scheduled Meeting of Council be cancelled or postponed due to a lack of quorum or no items provided for the agenda, a notice shall be posted on the doors of the Village Office and on the Village of Fort Simpson website by the Friday before the Regular Meeting. The notice shall be signed by the Mayor and Senior Administrative Officer.


